The Frequently Asked Question section offers information regarding the process of permit submission and fee schedules, inspection scheduling, and obtaining Certificates of Occupancy at the conclusion of their project.

We have also included a link to the entire Building Component Safety Information booklet, an invaluable asset to anyone planning a building project.
