MINUTES OF THE REGULAR MEETING OF THE KALAMAZOO AREA BUILDING AUTHORITY KALAMAZOO, MI August 19, 2025

Acting Chairperson, Justin Mendoza called the regular meeting of the Kalamazoo Area Building Authority (KABA) Board to order at approximately 2:14 P.M., at the KABA Offices, 2322 Nazareth Road.

Craig Sherwood / Representative from Kalamazoo Township Kim Lewis, Chairperson / Representative from Village of Richland

Also present were Building Official, Mike Alwine; KABA Attorney, Robb Krueger; and Office Coordinator/Board Liaison, Penny Cassidy.

Approval of Agenda – Alwine requested to add "Confirmation of the appointment of the B.O. recommended candidate for Building Inspector" as Item 5. e. <u>A motion was made by White to approve the agenda as amended, seconded by Bawa, and motion carried.</u>

Approval of Consent Agenda – <u>A motion was made by Visser to approve the Consent Agenda as presented, seconded by Bawa, and motion carried.</u>

Citizen Comments – There were no citizen comments.

Business -

- **5. a. General Insurance Renewal –** Alwine informed the board members of the changes made to the policy. White motioned to approve the General Insurance Renewal for 2025-2026 & allow Alwine to sign on behalf, seconded by Bawa, and carried with a vote 4-0.
- **5. b. 2026 Employee Wage Approval –** Bawa motioned to approve a 4% increase for the building official and the hourly employee's wages for 2026, seconded by White, and carried with a vote 4-0
- **5.** c. LTD/STD/Life Insurance Renewal White motioned to approve the 11/01/25 10/31/26 renewal of the STD/LTD/Life Insurance, seconded by Visser, and carried with a vote 4-0.
- **5. d. Acoustic Panels** Lewis suggested acoustic panels in the boardroom at the July 15th board meeting. <u>Visser motioned to approve the proposed purchase of the acoustic panels for the boardroom utilizing funds from the Building Maintenance & Repairs account of the 2025 budget, seconded by <u>Bawa, and carried with a vote 4-0.</u></u>
- **5. e. Confirmation of the appointment of the B.O. recommended candidate for Building Inspector** Alwine provided a synopsis of his recommendation for the incoming building inspector. Mendoza motioned to confirm, per the recommendation of the building official, the appointment of Jeff Kubiak as building inspector, with pending of obtaining a building inspector's registration from the

State of Michigan, seconded By Visser, and carried with a vote 4-0.

Board Member Comments – White provided an update of solar power in Richland Township.

Staff Member Comments – Alwine thanked the board members for supporting KABA.

There was no further business. The meeting was adjourned at approximately 2:40 P.M.

As part of a federal mandate, the in-network copayment for applied behavior analysis, or ABA, treatment will now be paid at the behavioral health office visit copay. HSA indexing

Effective with 2025 renewals, Blue Cross and BCN fully insured small groups will see the high-deductible health plan minimum deductible increase. We'll crosswalk all current \$1,600 aggregate and \$3,200 embedded high-deductible plans to \$1,650 and \$3,300 deductible plans respectively. This is due to the annual IRS HSA indexing of the minimum deductible.

Pharmacy

Opt-Out

This resolution is to opt out of PA 152 of 2011 (the 80/20 public employee health insurance coverage). The statute says that the resolution must be adopted prior to the beginning of the medical plan year, which is December 1, 2025 for KABA. The Kalamazoo Area Building Authority Board of Directors adopted the following Opt-Out Resolution:

RESOLUTION TO OPT OUT OF PA 152 FOR CALENDAR YEAR 2026

WHEREAS, Kalamazoo Area Building Authority is an intergovernmental authority located in Kalamazoo County, Michigan, that provides employee health insurance to qualified employees in accordance with MCL 41.110b et seq.; and

WHEREAS, by resolution the KABA Board has determined for 2026 that the Authority will pay more than 80% of the single person insurance premium coverage for qualified employees, as well the additional coverage for two-person and family insurance coverage; and

WHEREAS, MCL 15.568(1), being Section 8(1) of PA 152 of 2011, provides that a local unit of government may exempt itself from the requirements of the Act by a 2/3 vote of the Board; and

WHEREAS, the KABA Board desires to exempt the Authority from the requirements of the Act for the year 2026.

NOW THEREFORE BE IT HEREBY RESOLVED that Kalamazoo Area Building Authority hereby exercises its option under MCL 15.568 (1) and exempts itself from the requirements of PA 152 of 2011 for the year 2026.

Covered decks, porches and uninsulated sunrooms are calculated as utility use group in the Building Valuation Data Table.

Finished basements for all R-3 groups are calculated at \$74.00/ sq. ft.
